**Advertisement Notification No.: WBPDC/ Apprentices /2019/01**

The West Bengal Power Development Corporation Limited (WBPDC), a Government of West Bengal Enterprise, engaged in the business of Generation of Electricity in the State of West Bengal, invites applications from Indian Nationals as of Technician Apprentices under the Apprentices Act, 1961 for imparting training as per provisions of the said act, at its Power Stations / Projects located at different places across West Bengal as given below:-

**\*Note:** Only candidates having enrolled themselves under the National Apprentice Training Scheme (NATS) portal ([www.mhrdnats.gov.in](http://www.mhrdnats.gov.in)) shall be eligible to apply.

**B. AGE LIMIT:** Minimum 18 years and maximum 24 years as on **01.03.2019** for Technician Apprentice – Diploma in Engineering. However in case Technician Apprentice – Graduate in Engineering maximum age shall be 25 years as on **01.03.2019**.

**C. COMPENSATION / STIPEND:** Apprentices shall be paid stipend as per provisions of the Apprentice Act, 1961 and in reference to notification of the Ministry of Employment and Labour, Directorate General of Employment and Training, Govt. of India issued from time to time. Currently a Stipend of **Rs. 3,542/- per month** for Technician Apprentice -Diploma Engineer & **Rs.4,984.00/- per month** as applicable for Technician Apprentice – Graduate Engineer shall be paid during 01 (One) year apprenticeship.

**D. PERIOD OF APPRENTICESHIP TRAINING:** 12 months training commencing from execution of the Contract of Apprenticeship.

## E. GENERAL INSTRUCTION:

### i) RESERVATION:

- a) Reservation will be applicable as per the provisions of the Apprentice Act, 1961 and Apprenticeship Rules 1992 as amended from time to time.
- b) Applicants belonging to SC (Schedule Caste) / ST (Scheduled Tribe) / OBC (Other Backward Classes) – Non Creamy Layer shall produce their caste certificate in prescribed format issued by the Competent Authority.

### ii) Candidates who have previously undergone Apprenticeship Training and / or presently undergoing Apprenticeship Training and / or presently in employment elsewhere being registered for Apprenticeship Training elsewhere are **not eligible to apply**.

### iii) Selection Process:

- a) Candidates shall be called for Personal Interview (PI) based on percentage of marks achieved in Diploma/Degree in Engineering in Mechanical / Electrical Engineering / Electronics & Instrumentation streams, as the case may be @ **1:5 ratio** taking into consideration the respective reservation norms. The Venue of the Personal Interview (PI) shall be at the Board of Practical Training (Eastern Region), Block-EA, Sector-1, Salt Lake City (Opp. Labony Estate), Kolkata, 700064.
- b) Selected candidates shall undergo Medical Examination and will have to be declared 'Medically Fit' before execution of the Contract of Apprenticeship.
- c) Verification of credentials shall be done prior to conduct of Personal Interview only and in case of any deviation or non-conformity with the desired qualification, candidature of the candidate shall be summarily rejected.
- d) No TA / DA will be paid to the applicants called for any stage of the selection process.
- e) The Selected candidates must execute a **Contract of Apprenticeship** for a period of one year of training as per provisions of the Apprentices Act, 1961 and rules framed there under.
- f) After completion of such apprenticeship training / stipulated period, the Apprenticeship Contract shall automatically cease. There shall be **No obligation on part of WBPDCCL to offer any employment thereafter**.
- g) Suppression of facts will lead to disqualification at any stage of the selection process.
- h) WBPDCCL reserves the right to increase / decrease the number of seats for apprenticeship training.
- i) Students who have completed Post Graduate qualification in Engineering (M.E. / M. Tech / MBA) are not eligible.
- j) Only the above mentioned subject fields will be considered. Any claim for equivalence to the subject fields will not be considered.

## MANDATORY DOCUMENTS REQUIRED:

01. Duly signed and filled in application blank / application form.
02. 02 copies of recent passport size photograph.
03. Enrolment number after registering themselves on the National Apprenticeship Training Scheme (**NATS**) web portal ([www.mhrdnats.gov.in](http://www.mhrdnats.gov.in))
04. Self attested copies of:
  - a. Date of Birth (matriculation certificate / mark sheet / admit card or Birth Certificate).
  - b. Qualifying degree / diploma certificates with all semester wise / year wise mark sheets, as applicable.

## F. HOW TO APPLY:

Eligible candidates will be required to apply online only (on the internet) through the link 'APPLY ONLINE' link on the WBPDCCL portal. No other mode of application shall be accepted.

1. Before registering / submitting applications on the website, the candidates should possess a valid:
  - a. Enrolment number obtained after registering themselves with the NATS web portal ([www.mhrdnats.gov.in](http://www.mhrdnats.gov.in)).
  - b. E-mail ID
  - c. Mobile number
  - d. Scanned copy of recent passport size coloured photograph (not more than 50KB size) of the candidate, as applicable and scanned signature (not more than 20KB size) of the candidate, as applicable.

2. The application is liable to be rejected if the uploaded photograph / signature are not clear and recognizable. Candidates are advised to upload their most recent photograph and retain sufficient numbers of the same photograph to be used at later stages of the selection process if called for.
3. Category (General/SC/ST/OBC(A)/OBC(B)) as submitted at the time of application cannot be changed thereafter and no benefit of other category reservation will subsequently be made admissible at any stage of the selection process. Category as mentioned at the time of submission of application shall remain unaltered during the entire training period.
4. Candidates must write their name as it appears in the educational certificate of Secondary or equivalent examination. In case of change of name at a later stage necessary legally accepted documentary proof is to be submitted at the time of interview.
5. Candidates shortlisted for interview would be required to furnish documents regarding proof of Date of Birth, Qualification, Category, Application slip etc. at the time of interview, as per intimation to be given to the shortlisted candidates.
6. All qualification certificates should be issued by a recognized Board / Institute / University only. Wherever CGPA or letter grade in a qualifying degree is awarded, equivalent percentage of marks should be indicated in the application form as per norms adopted by the University / Institute. Candidates are required to submit a Certificate to this effect from the respective University / Institute at the time of Interview.
7. While filling the online application, candidates must carefully follow all necessary steps as referred above. Incomplete application / application not fulfilling any eligibility criteria will be rejected summarily. No further communication will be entertained from any applicants in this regard.
8. Candidates can access the online application form at [www.wbpdcl.co.in](http://www.wbpdcl.co.in). Online submission will remain open from **15.03.2019 to 01.04.2019**.
9. All correspondence with candidates shall be done either through E-mail / WBPDCCL website only. All information regarding Interview, Call letters, etc. shall be provided through E-mail / WBPDCCL website only. **No hardcopy mailing of Interview Call letters shall be done by the WBPDCCL.** Responsibility of receiving, downloading and printing of Admit Card / Call Letter shall be that of the candidate. The WBPDCCL will not be responsible for any loss of e-mail sent due to invalid / wrong E-mail ID provided by the candidate or delivery of e-mails to SPAM / BULK mail folder etc.

#### **G. GENERAL INSTRUCTIONS:**

01. Before applying the candidate should ensure that he/she fulfills the eligibility criteria and other norms mentioned in the advertisement.
02. Applicants are required to apply through [www.wbpdcl.co.in](http://www.wbpdcl.co.in) website. No manual / paper application will be entertained. Candidates are advised to keep in touch through the WBPDCCL website for details and updates relating to this employment notification, if any.
03. SC / ST / OBC(A) / OBC(B) the purpose of this notification means applicants belonging to 'Scheduled Caste' / 'Scheduled Tribe' / 'Other Backward Classes' category candidates respectively. Candidates applying from states other than West Bengal shall be treated as General category candidates.
04. Date of Birth will be taken as that mentioned in the birth certificate issued by the Competent Authority / Certificate or Admit card of Class X or equivalent examination. No other proof of date of birth shall be accepted.
05. Having successfully registered oneself at the WBPDCCL ([www.wbpdcl.co.in](http://www.wbpdcl.co.in)) website does not entitle one to be eligible to appear for Personal Interview or any subsequent test(s). **Verification of credentials shall be done prior to conduct of Personal Interview only and in case any deviation from or non-conformity with the desired qualification candidature of the candidate shall be summarily rejected.**
06. Candidature of candidates is liable to be rejected at any stage of the selection process or even after execution of the Contract of Apprenticeship, if any information provided by the candidate is found to be false or is found not to be in

conformity with the eligibility criteria so mentioned in the advertisement. Screening and selection of candidates will be based on the details provided by the candidate, hence it is necessary that the applicants furnish accurate, full and correct information. Furnishing wrong / false / incomplete information will lead to disqualification and the WBPDCCL will NOT be responsible for any consequence arising out of furnishing such wrong / false information by the candidate.

07. Request for change of mailing address / category / discipline / qualification once declared in the online application form will not be entertained.
08. Candidates should apply for any ONE discipline only. Applications made for more than one discipline may render all the applications of the candidate invalid.
09. Candidates who had undergone or is undergoing training or is presently in employment after attainment of qualification shall NOT be eligible for being engaged as Technician Apprentice i.e. Graduate in Engineering and Diploma in Engineering.
10. **The applicants should NOT have completed three years after passing of the qualifying examination as on 01.01.2019 i.e,** candidates having passed the Degree / Diploma in Engineering in the year 2016, 2017, 2018 are only eligible to apply.
11. No TA or other expenses will be made admissible to the candidates appearing for the interview etc.
12. Any canvassing or personal follow up with an intention of inducing the process of selection of apprentice by and on behalf of any candidate shall lead to immediate cancellation of candidature.
13. The WBPDCCL reserves the right to withdraw / cancel the advertisement / selection process if circumstances so warrant without assigning any reason thereof.
14. Candidates prior to applying on the WBPDCCL website have to enroll themselves on the NATS website (<http://www.mhrdnats.gov.in>).
15. In case of any dispute, the legal jurisdiction shall be that of the Hon'ble High Court, Calcutta.
