The engineering Graduates or Diploma Holders in Engineering and Commercial Practice, WHO HAVE PASSED OUT DURING THE YEAR 2021, 2022 and 2023 are only eligible to undergo apprenticeship i.e. only if they join within 3 years of acquiring the Degree (i.e.3 Years from the month and year of passing as specified in the Degree certificate) and if this time limit is crossed at the time of offer, they will not be offered the training position, even if they are empaneled/waitlisted. Candidates who have passed the qualifying examination earlier than 2021 are not eligible.
