Online applications are invited in prescribed form available herewith in the official website of the High Court of Tripura (<http://thc.nic.in>) from persons who are not below 18 years of age and not more than 40 years of age in case of others and 45 years in case of candidate belonging to Scheduled Castes & Scheduled Tribes as on **03.12.2023** for filling up of the following 02 (two) vacant posts of Driver in the establishment of the **Tripura Judicial Academy, Agartala:**

Category of Post	Name of the Post	Number(s) of Vacancies	Scale of pay
Group-C	Driver	02 (two)	Pay Band – 2 Rs. 5700-24000/- with Grade Pay Rs.2200/- (Cell-1, Level-7 of the Pay Matrix, 2018 subject to revision by the Government from time to time).

The aforesaid 02 posts are meant for unreserved category. The number of posts to be filled up is subject to increase or decrease and a panel of select list will be prepared based on the merit of Written Examination and Driving Test and it will remain valid for 1(one) year from the date of publication of the result.

A candidate must be a citizen of India as defined in Articles 5 & 6 of the Constitution of India and must be a Class VIII passed or equivalent having a validly issued commercial Driving license with experience in driving.

ST/SC candidates of other States should apply as general candidate alongwith application fees prescribed for candidates of general category.

The application fee for UR category applicant is **Rs.400/- (Rupees four hundred only)** and that of reserved category (SC/ST) applicant is **Rs.200/-**

(Rupees two hundred only). Fees once deposited will not be refunded or adjusted for any other recruitment in future. Candidates are to deposit fees by using Credit Card (Visa/Master/Rupay), Net Banking, Debit Card (Visa/Master/Rupay), Wallets & Cash Cards & UPI only. No other mode of payment will be accepted. Bank charge may apply.

The candidate shall have to appear in the Written Test of 100 marks of MCQ/ Objective type questions relating to General Knowledge, Current affairs & English, etc. followed by Driving Test of 50 marks. Only those candidates who qualify in the Written Test shall be called for Driving Test. Ratio of candidates short listed through Written Test shall be 1:6 i.e. for 01 (one) advertised post 06 candidates will be short listed for Driving Test.

Disqualification for appointment– No person shall be eligible for appointment to the service-

- (a) Unless he is a citizen of India; or
- (b) If he has been dismissed from service by the Government, Central Government, High Court, statutory or Local Authority; or
- (c) If he has been convicted of an offence involving moral turpitude; or
- (d) If he has more than one spouses living; or
- (e) If he directly or indirectly tries to influence the recruiting authority by any means.

IMPORTANT NOTES

- i) Online Application:
 - a) Candidates have to submit application through Online Application Portal only. The High Court will not entertain any hard copy application. Before submission of online application, the candidates are to read the instructions carefully in the 'How to Apply' segment of the Online Application Portal.
 - b) Online Application Portal will be available on the High Court's Website (<https://thc.nic.in>) from **03.11.2023 (from 11:00 A.M.) to 03.12.2023 (upto 05:00 P.M.)**. To apply the candidates have to click on the 'Recruitment' tab in the Home page of the High Court's website.

- c) Candidates should avoid submitting multiple applications. However, due to any unavoidable circumstances, if any candidate submits multiple applications then he/she must ensure that the application with latest Registration Number is complete in all respect.
- d) In case of multiple applications, the application with the latest Registration Number shall only be entertained by the High Court and Fee paid against one Registration Number shall not be adjusted against any other Registration Number.
- ii) Candidates who are eligible for Written Test will be asked for scrutiny of original marks-sheets/certificates/documents before appearing in the Written Test.
- iii) **The candidates already in Government Services shall apply either through proper channel or attach 'No-Objection Certificate' from his/her employer.**
- iv) Candidates shall have to bear their own expenses for appearing in the Selection test.
