- **2.** All appointment in pay level-12 and 13A2 under Institute shall be made on probation period of two years from the date of joining the Institute.
- **3.** Applicants seeking reservation benefits available for SC, ST, OBC (NCL), PwD and EWS must be in possession of the certificates in the format prescribed by the Government of India in support of their claim at the time of application.
- **4.** The number of vacancies indicated in the notification is tentative. IIIT, Surat reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIIT Surat reserves the right not to fill any of the posts advertised.
- **5.** The appointment of the selected candidates is subject to being found medically fit as per the requirements of the Institute.
- **6.** The person employed on regular employment in Government and Semi-Government Organization, the public sector, Autonomous bodies of Govt. of India, or state government must apply through the proper channel. In such case, the candidates are advised to send an advance copy so as to reach before the stipulated time limit. In such cases, the applications are required to bring a **No Objection Certificate (NOC)** from his/her employer at the time of appearing interview.

8. Submission of Documents / Certificates:

The <u>self-attested copies</u> of the following documents are required to be attached with the Application Form failing which the application shall not be evaluated and shall stands summarily rejected:

- e) Graduation Degree Certificate.

- g) PhD Award Certificate / Provisional Award Certificate (Notification).
- h) NOC from the Current Employer.
- i) Service Certificate for all the previous employment issued by Cadre Controlling Authority / Personnel Officer in the prescribed pro-forma or consisting of all the designations, pay-scales, type of employment etc.
- j) EWS and OBC-NCL Certificate (wherever applicable) issued in the current Financial Year (i.e. issued after 1st April 2024) only as per Central Government Format.
- k) **Cast Validity Certificate** for SC/ST/OBC-NCL candidates belonging to the State of Maharashtra.
- SC/ST/PwD Certificates (wherever applicable) in prescribed pro-forma of Central Government Only.

- **9.** Submission of application, Possession of essential qualification and experience does not provide right to be called for interview. If a candidate is called for test/interview, he/she will not get any right for selection and appointment. There is no system or practice to send any written communication to candidates not called for interview or who are not selected after interview, indicating the reasons for rejection. The Institute has the option to limit the number of candidates to be called for interview considering number of positions to be filled in, specialization requirement, subject discipline, etc.
- **10.** The experience certificate should be in proper format i.e., it should be on the organization's letter head, bearing the date of issue, specific period of work, nature of duty, designation, pay drawn for each position, duly certified by the concerned issuing authority. Original certificates should be produced at the time of selection process as well as while joining.
- 11. Incomplete application without self-attested copies of relevant certificate(s)/ document(s) are liable to be summarily rejected. All the details furnished in the application will be treated as final and no changes will be entertained. The responsibility of entries in the application form lies with the Applicant.

- **15.** The Institute will verify the antecedents or documents submitted by a person at the time of appointment or during the tenure of the service. - **3.** Only the eligible candidates staying aboard would be allowed to attend the Demo/Interview through Online Mode subject to the approval of the Competent Authority. The request to this effect should have to be emailed 10 days before the scheduled date for Demo/Interview.
