# Corrigendum

It is hereby announced for general information of the candidates that the Commission had advertised 1633 posts of Post Graduate Teachers in the subject of Computer Science for Rest of Haryana Cadre vide Advt. No. 26/2023 and 78 posts of Mewat Cadre vide Advt. No. 36/2023 in Secondary Education Department, Haryana. Commission has decided to re-open the portal for inviting the online application forms from all the eligible candidates. The candidates are hereby advised to apply through online link i.e. <a href="http://hpsc.gov.in">http://hpsc.gov.in</a>. The link will be available from 28.04.2025 & upto 5:00 PM on 02.05.2025.

Further, in compliance of directions dated 13.12.2023 passed by the Hon'ble Punjab and Haryana High Court in CWP No. 13816 of 2020 – Rajesh Kumar & others, it has been decided by the Commission that only the candidates who possess the qualifications prescribed by the National Council for Teacher Education (NCTE) for PGT (Computer Science) would be considered eligible to participate in the selection process. The qualifications prescribed by the NCTE for PGT (Computer Science) are as under:-

"Post Graduate with at least 50% marks (or its equivalent) from recognized University and Bachelor of Education (B.Ed.) from National Council for Teacher Education recognized institution. Or

Post Graduate with at least 45% marks (or its equivalent) from recognized University and Bachelor of Education (B.Ed.) from National Council for Teacher Education recognized institution (in accordance with the National Council for Teacher Education) Form of application for recognition, the time limit of submission of application, determination of norms and standards for recognition of teacher education programmes and permission to start new course or training) Regulations, 2002 notified on 13.11.2002 and National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2007 notified on 10.12.2007) Or

Post Graduate with atleast 50% marks (or its equivalent) from recognized University and B.A. B.Ed./B.Sc.Ed. from any NCTE recognized institution. Or

Post Graduation with a minimum 55% marks or equivalent grade and three-year integrated B.Ed.-M.Ed."



In addition to above, the candidates having the above qualification but not having B.Ed. qualification would also be considered.

After issuance of advertisement No. 26/2023 and 36/2023, the Govt. has issued notification No. 22/163/2024-5HR-III dated 13.11.2024 regarding sub-categorization of Scheduled Castes of Haryana. This Corrigendum is being issued in view of the notification dated 13.11.2024 issued by the Government.

# A. Notification No. 22/163/2024-5HR-III dated 13.11.2024

### 1. SC candidates who have already applied:-

All the candidates of Scheduled Caste category who have already applied in response to advertisement dated 24.06.2023 are directed to update their online application form and mention their respective category as DSC or OSC as the case may be. Further all the candidates who now come in DSC or OSC category are directed to submit/upload the latest DSC or OSC category certificate issued as per notification No.22/163/2024-5HR-III dated 13.11.2024. After updation of information, please download a copy of the same & read it carefully. After checking the correction of the information, sign it & upload the same.

# 2. DSC and OSC Candidates applying in response to this corrigendum:-

All the candidates of DSC and OSC category who had not applied earlier and are now applying after issuance of this corrigendum, would be required to submit online application form clearly mentioning their category as DSC or OSC and they would be required to upload their latest DSC/OSC certificate issued by the competent authority issued as per notification No.22/163/2024-5HR-III dated 13.11.2024 along with the online application form.

- 3. The SC candidates who had already submitted their online applications but they could not upload the duly signed application form after taking out the printout or had erroneously filled wrong particulars relating to their category, qualification etc. in their previous application form, such candidates would have to cancel their already filled application form and them submit fresh application form by paying the requisite fee. The fee already paid with the earlier application form will not be adjusted against the new application form.
- **4.** The bifurcation of posts meant for Scheduled Castes into Deprived Scheduled Caste and Other Scheduled Caste as per Notification No. 22/163/2024-5HR-III dated 13.11.2024 will be notified lateron.

# B. BC-A (Non-Creamy Layer), BC-B (Non-Creamy Layer) and EWS Candidates.

# 1. BC-A, BC-B and EWS candidates who are applying in response to this Corrigendum:-

(a) All the candidates belonging to BC-A (Non-Creamy Layer), BC-B (Non-Creamy Layer) category applying in response to this Corrigendum would have to upload a certificate on the online portal which has been issued as per Haryana Government



instructions No. 22/132/2013-1GS-III dated 22.03.2022, Government notification No.40/13/2024-1SW dated 16.07.2024 and as amended from time to time. This certificate should be issued between 01.04.2025 till the closing date of the Corrigendum. Certificates issued prior to 16.07.2024 or after the closing date of corrigendum would not be considered.

(b) Similarly the EWS category Candidates applying in response to this Corrigendum are required to upload a certificate on the online portal which has been issued as per Haryana Government instructions issued vide No. 22/12/2019-1GS-III dated 25.02.2019. This certificate should be valid for the financial year 2025-2026 and should be issued between 01.04.2025 till the closing date of the Corrigendum. Certificates issued prior to 01.04.2025 or after the closing date of corrigendum would not be considered.

# 2. BCA, BC-B and EWS candidates who have already applied :-

(a) All the candidates of BC-A (Non-Creamy Layer), BC-B (Non-Creamy Layer) and EWS who have already submitted their online application in response to Advertisement No. 26/2023 and 36/2023 are directed to submit a fresh certificate on the online portal. After updation of information, please download a copy of the same & read it carefully. After checking the correctness of the information, sign it & upload the same.

### C. ESM/DESM category candidates

# 1. ESM/DESM Candidates who have already applied:-

- (a) All the candidate belonging to ESM category who have already submitted their application in response to Advertisement No. 26/2023 and 36/2023 are directed to upload copy of their Identify Card issued by Zila Sainik Board. The ESM ID Card No., Date of Issue of ESM ID Card and Date of Discharge from service should be entered in the online application portal.
- (b) All the candidate belonging to DESM category who have already submitted their application in response to Advertisement No. 26/2023 and 36/2023 are directed to upload their Eligibility Certificate issued by Zila Sainik Board. The Serial No. of eligibility register, date of issue of the DESM certificate and details regarding renewed upto be entered in the online application portal.



# 2. ESM/DESM Candidates who are applying in response to this Corrigendum

- (a) The candidate belonging to ESM category who are applying in response to this Corrigendum are directed to upload copy of their Identity Card issued by Competent Authority/Zila Sainik Board. The ESM ID Card No., Date of Issue of ESM ID Card and Date of Discharge from service should be entered in the online application portal.
- (b) The candidate belonging to DESM category who are applying in response to this Corrigendum are directed to upload their Eligibility Certificate. The Serial No. of eligibility register, date of issue of the DESM certificate and details regarding renewed upto be entered in the online application portal.

#### Note:-

- I. All candidates are advised to read the instructions mentioned in the advertisement No. 26/2023 and 36/2023 carefully, before submitting the online applications form. Further, incomplete and defective application form shall be summarily rejected.
- II. The candidates, who have applied earlier against advertisement No. 26/2023 and 36/2023, need not apply again.
- III. The candidates who are applying against this corrigendum, their educational qualifications and other eligibility etc. will be determined on the last date for submission of online application form to the Commission i.e. 02.05.2025 and age will be determined as on 18.07.2023 as per the advertisement.
- IV. The candidates who have applied earlier against advertisement No. 26/2023 and 36/2023 but could not upload the duly signed application form after taking out the printout, such candidate are directed to apply afresh through online mode, after cancelling their previous application form.
- V. The candidates who had erroneously filled wrong particulars relating to their category, qualification etc. in their previous application form can also apply afresh through the online mode, only after cancelling their previous application form.
- VI. The other terms & conditions mentioned in the advertisement No. 26/2023 and 36/2023 dated 24.06.2023 shall remain unchanged.
