Candidates are required to mandatorily complete the Google Form through the link provided in the website of the ARIAS Society under the Recruitment page (<u>https://arias.in/career.html</u>) and upload scanned copy of the duly filled-in & signed CV as per the Prescribed Format along with scanned copies of the self attested supporting documents/ certificates in the manner mentioned in the website.
- c. The start date of submission of online application shall be **22nd May-2025**, **10:00AM (IST)** and the Last date of submission of online application is **05**th **June-2025**, **11:59PM (IST)**.
- d. Application not submitted in the above mode or application submitted after the deadline mentioned above shall be summarily rejected.
- 2. Only Shortlisted candidates will be intimated and called for Written Test and/or Interview. Depending on the number of candidates shortlisted for a position, the ARIAS Society may hold Written Test followed by Personal Interview or may hold only Personal Interview. Both the Written Test (if held) and the Personal Interview will be held in the ARIAS Society, Khanapara, Guwahati (Assam). No Travelling/ Boarding Allowance shall be paid by the ARIAS Society to the candidates for appearing in the Written Test/ Personal Interview.
- 3. Candidates must present all the original certificates/documents along with one set of self-attested copies during the time of the interview. The original documents will be returned once they have been verified against the self-attested copies provided by the candidate through email. If at any stage, it is found that information furnished in the application or supporting documents by the candidate is misleading/ misrepresented/ incomplete/ false, candidature shall be liable for cancellation.
- 4. The Cost to Project (CTP) shall be fixed within the indicative range cited above, based on the performance of the selected candidate in the written test (if held) and the interview.
