- (5) Candidates are required to bring a signed printout of the application along with the originals of the documents submitted online at the time of joining CHESS, Hyderabad.
- (6) Reservation for SC/ST/OBC categories will be applicable as per provisions of Apprentice Act 1961, Apprentice Rules, 1992 and Apprenticeship (Amendment) Rules, 2015.
- (7) Last date for the receipt of application: 21 days from the date of advertisement in Employment News. Online Applications after the last date would not be accepted.

Terms & Conditions for selection of Apprentices:-

- (1) Selection will be made on the basis of Percentage of marks secured by candidates at essential qualification level.
- (2) Only pass-out candidates (passing their respective courses in 2022, 2023 & 2024) can apply. Candidates who have passed the qualifying examination earlier then 2022 are not eligible.
- (3) Candidates with post-graduate qualifications are not eligible to apply.
- (4) Those candidates who have completed the qualify examination as regular candidates are only eligible to apply.
