NOTIFICATION

1. Applications are invited from the eligible Indian Citizens who are Natives/Residents of the Union Territory of Puducherry for Direct Recruitment to the post of Police Constable (Group-"C"- Non-Gazetted, Non-Ministerial) in the Police Department, Puducherry. The details are given below:-


- Already sufficient representation has been given to Women under these categories. Hence, no reservation is entitled for Women under these categories in this recruitment. Hence, the Women candidates belonging to these categories will be considered only under General / Unreserved category for the post of Police Constable in this recruitment.

1.1 Abbreviations:

UR-Un-Reserved, **SC**-Scheduled Castes, **OBC**- Other Backward Classes, **MBC**- Most Backward Classes, **BCM**- Backward Class Muslims, **EBC**- Extreme Backward Classes, **BT**-Backward Tribe, **ST**-Scheduled Tribe, **EWS**- Economically Weaker Section, **XSM**- Ex-Servicemen, **MSP**-Meritorious Sports Persons.

1.2 Note:-

- (i) The vacancies notified are existing as well as anticipated. The Government reserves the right either to enhance or to reduce the number of vacancies notified depending upon the actual number of vacancies, as the case may be, at the time of selection. Firm vacancies will be determined in due course. Updated vacancies, if any, will be made available on the recruitment portal, before the examination.
- (ii) The Government reserves the right to cancel the recruitment process also without assigning any reasons. No interim enquiry will be entertained.
- (iii) 33% of Horizontal Reservation is applicable for women as per G.O.Ms.NO.76 dated 14.12.2016 of Home Department, Puducherry.



2. EDUCATIONAL QUALIFICATION FOR ELIGIBILITY:

2.1 A Pass in Standard 10+2 or its equivalent.

3. AGE LIMIT

3.1 Not exceeding 22 years as on 12.09.2025. Age limit is relaxable in respect of SC/OBC/MBC/BCM/EBC/BT/ST/Ex-Servicemen, Widows / Divorced Women / Women judicially separated from their husband and who are not re-married and Meritorious Sports Persons as detailed below:

3.2 Requirement of Age for candidates belonging to various category are given in **Part-II** of this Notification.

4. NATIVITY/ RESIDENCE:

4.1 Those who are natives of Union Territory of Puducherry and residents by continuous residence in the U.T. for the last 5 years immediately preceding the date of notification only are eligible to apply for the posts.

4.2 The applicants on selection shall furnish the fresh Nativity/Residence Certificate issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar at the time of Certificate verification.



5. COMMUNITY CERTIFICATE

- 5.1 The selected applicants shall submit a fresh Community Certificate for SC/ST/MBC/OBC/EBC/BCM/BT (mention only the categories for which vacancies has been earmarked) obtained in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar at the time of certificate verification.
- 5.2 Candidates selected under SC quota should furnish fresh Community Certificate issued under "The Constitution (Puducherry) Scheduled Castes Order, 1964 " or "**The Constitution (Puducherry) Scheduled Castes Order, 2002**" in respect of "**Puthirai Vannan**".
- 5.3 Applicants applying under ST Quota should furnish Community Certificate issued under "**The Constitution (Puducherry) Scheduled Tribes Order, 2016**".

6. CERTIFICATE FOR EWS CANDIDATES:

- 6.1 The candidates selected under EWS category should submit Income and Asset Certificate obtained in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar at the time of Certificate verification. The crucial date for submitting income and asset certificate by the candidate will be the closing date for submission of online application i.e 12.09.2025. The certificate should have been issued for the financial year 2024 -2025 and shall be valid for the year 2025-2026.

7. EX-SERVICEMEN:

7.1 **Explanation:** An 'ex-serviceman' means a person:

7.1.1 *Who has served in any rank whether as a combatant or non-combatant in the regular Army, Navy and Air Force of the Indian Union, and*

7.1.1.1 *Who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his pension;*

or

7.1.1.2 *Who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension;*

or

7.1.1.3 *Who has been released from such service as a result of reduction in establishment;*

7.1.2 *Who has been released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service; or*



7.1.3 *Personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or 8 circumstance beyond their control and awarded medical or other disability pension;*

or

7.1.4 *Personnel, who were on deputation in Army Postal Service for more than six months prior to the 14th April, 1987;*

or

7.1.5 *Gallantry award winners of the Armed forces including personnel of Territorial Army;*

or

7.1.6 *Ex-recruits boarded out or relieved on medical ground and granted medical disability pension.*

7.2 *The applicants who apply under Ex-Servicemen category should necessarily submit the Discharge Certificate & Registration particulars with the Department of Sainik Welfare, Puducherry.*

7.3 ***Age relaxation for Ex-Servicemen is not admissible to sons, daughters and dependents of Ex-Servicemen. Therefore, such candidates should not indicate their category as ex-servicemen.***

8. WIDOWS/DIVORCED WOMEN/WOMEN JUDICIALLY SEPARATED FROM THEIR HUSBAND AND WHO ARE NOT RE-MARRIED:

8.1 The applicants who apply under the category of Widows / Divorced Women / Women Judicially separated from their husband and who are not re-married, should necessarily submit a Certificate issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar to the effect that they are not re-married, at the time of certificate verification.

9. MODE OF RECRUITMENT / PATTERN OF EXAMINATION:

9.1 The vacancies in the above said post will be filled through the different stages of selection process as detailed below:-

9.4 **Note :**

- (i) *All the above events are compulsory.*
- (ii) *Each stage is qualifying stage by itself for the next stage i.e. only the candidates who qualify in the Physical Standard Test will be eligible to the Stage I of the Physical Efficiency Test and so on.*
- (iii) *Three chances will be given to qualify in the long jump and high jump.*
- (iv) *Ex-servicemen are exempted from the Physical Efficiency Test. They will be eligible to appear for the Written Test if they qualify in the Physical Standard Test.*

9.5 **APPEAL :** The appeal made by any candidate on the same day of the Physical Standard Test / Physical Efficiency Test will be examined and decided by the Committee constituted for this purpose.

10. Written Examination:

All candidates who qualify the physical standard test and physical efficiency test shall undergo a written test. The questions will be of **10+2** standard of objective type. The question papers will be in two parts each of two hours duration.

Questions may be asked from any topics appropriate to the Educational Qualification level prescribed for the post of Police Constable.

Negative mark of 0.25 will be awarded for every wrong answer and multiple answers will be treated as a wrong answer. Candidates are, therefore, advised to keep this aspect in mind while answering the questions.

The Question paper will be in English and in any one of the regional languages namely, Tamil or Telugu or Malayalam. Therefore, the candidates should indicate the choice of the language in which they prefer to write the examination, in the on-line application.

Questions asked on English Language, Literature, Grammar and Comprehension and General Knowledge on English shall not be translated in other language.


Answering would be in the form of shading the correct answer by using **BLACK BALL POINT PEN** only and the applicants are permitted to take the carbon copy of their answer sheet along with their question booklet.

The answer key will be published in the recruitment website <https://recruitment.py.gov.in> after completion of Examination process.

10.2 FOR CANDIDATES APPLYING UNDER MSP QUOTA:

The selection of candidates for the vacancies reserved under Meritorious Sports Persons quota will be made on the basis of their achievements in the sports as per the instructions in G.O.Ms. No.02 dated 04.10.2024 of the Directorate of Sports and Youth Affairs, Puducherry. There will not be any written examination for the selection of candidates under MSP.Quota. However, they have to undergo the Physical Standard Test, Physical Efficiency Test.

Further, the Meritorious Sports Person category candidates may also participate in the direct recruitment written Examination along with other candidates provided if they are within the age limit under the category to which they belong to.



11. Minimum qualifying marks prescribed for the written examination:

- 11.1 A provisional select list will be drawn for the post of Police Constable from the overall merit list subject to observance of rules of reservation.

The candidates shall secure a minimum qualifying percentage of marks in the Written Competitive Exam as follows:

Unreserved	:	30%
MBC / OBC / EWS / EBC / BCM / BT	:	25%
SC / ST / XSM	:	20%

A candidate must appear in both Paper – I and Paper – II to become eligible to be included in the merit list, subject to obtaining the minimum qualifying mark prescribed above in each paper. The merit list will be prepared based on the aggregate marks obtained in both the papers.


The Government reserves the right to relax the qualifying marks in exceptional circumstances.

- 11.2 A wait list will also be drawn, the validity of which will be two years from the date of declaration of result / publication of select list.
- 11.3 The wait list will be operated in the event of occurrence of a vacancy caused in the select list due to rejection of candidature for non-production of required certificates, non-appearance of candidate for certificate verification, non-joining of candidate within the stipulated time allowed for joining the post or when a candidate joins but resigns or dies within a period of one year from the date of joining etc.
- 11.4 The answer key will be published in the recruitment website <https://recruitment.py.gov.in> after completion of Examination process.
- 11.5 Candidates may go through the Answer Keys and submit online representations, if any, within the stipulated time limit.
- 11.6 Representations received through any other mode e.g. letter, application, email, etc. will not be entertained. Representation regarding the Answer Keys will be examined and decided by the Key Challenge Committee.
- 11.7 The decision of the Key Challenge Committee in this regard will be final.
- 11.8 Final Key will be published along with the results of exam.
- 11.9 There shall be no provision for re-evaluation/re-checking of the scores at any stage of the examination. No correspondence in this regard will be entertained.

11.10 Resolution of Tie Cases:

In the event of tie in scores of candidates in the examination, merit will be decided by applying the following criteria, one after another in the given order, till the tie is resolved:

- (i) Date of birth, with older candidate placed higher.
- (ii) Alphabetical order in which the names of the candidates appear.



12. MEDICAL EXAMINATION:

The candidates who pass the Physical Standard Test, Physical Efficiency Test and Written Examination shall be medically examined by the Specialists in General Hospital, Puducherry and finally certified by the Assistant Director (RMO) under the supervision of Medical Superintendent, General Hospital, Puducherry as detailed below:-

Medical standards:

(1). Eye sight :

I. Distant Vision

(A) Normal-Both eyes should be 6/6.

(OR)

(B) Better eye with correction 6/6.

(C) Worse eye vision 6/12 (without correction).

(OR)

(D) Both eyes should be 6/9.

II. Near Vision

(E) Normal – Both eyes should be J_I.

(OR)

(F) Better eye with correction J_I and worse eye without correction J_{II}.

III. Colour Blindness

(G) Free from colour Blindness

2. Hearing :

Free from any disability.

3. Defects or Deformity :

Free from any defect or deformity of limbs.

4. Disease :

Free from hernia, piles, respiratory disease, diabetes or any other disease, which will adversely affect the work of Police Constable.

5. Other :

- (i) Should not be flat-footed or suffering from knocked-knees and bow legs; and
- (ii) Should not be obese BMI more than 29.9 kg./m² will be discarded.

13. DATE AND VENUE OF EXAMINATION:

- 13.1 Physical Standard Test, Physical Efficiency Test, Certificate verification and Medical examination will be held in Puducherry only.
- 13.2 The Written Competitive Examination will be conducted in **Puducherry only.**
- 13.3 The Government reserves the right to cancel any centre without assigning reasons.
- 13.4 The candidates opted for a particular centre may be accommodated in any other centre of the Department's choice for administrative reasons.
- 13.5 **The exact date, time and venue of the examinations will be intimated in due course in the recruitment website <https://recruitment.py.gov.in> & also in leading Newspapers.**
- 13.6 No request for change of Exam Centre will be entertained.
- 13.7 The date and time of downloading of hall ticket will be intimated in the recruitment portal.
- 13.8 No TA/DA will be paid for attending the PST/PET and Written Competitive Exams except SC/ST candidates of outlying regions who will be paid TA as per rules.

14. TRAINING:

The Selected candidates will be placed under probation for a period of **TWO YEARS** from the date of joining the post as per Recruitment Rules (**including the Basic Training for one year**).

15. HOW TO APPLY AND LAST DATE FOR APPLICATION:

Applicants fulfilling the eligibility criteria as mentioned above may apply online only through the official website <https://recruitment.py.gov.in> from **13.08.2025 (10.00 a.m.) to 12.09.2025 (03.00 p.m.)**


16. PROCEDURE FOR SUBMISSION OF ONLINE APPLICATION:

- 16.1 The applicants have to register with their Mobile Number in the online portal "<https://recruitment.py.gov.in>" for applying through online.
- 16.2 They will receive exclusive Username and Password through SMS in the registered mobile number provided. The applicants may login the online portal using the exclusively allotted Username and Password and shall apply for the post.
- 16.3 The applicants are advised to change the default Password received in their mobile after first login.
- 16.4 It is the applicant's responsibility to maintain the secrecy of the password and it should not be disclosed to anyone.

- 16.5 The applicants may view, print & check the status of their application and download the Hall Ticket by logging in the online portal using the username and password. Hence, they are advised to keep the user name and password safe for future reference until the recruitment process is completed in its entirety.

17. Photograph & Signature uploading:

- 17.1 Applicants shall upload their latest Photograph and Signature using either option 1 (or) option 2 provided in the recruitment portal as given below:-
- 17.2 Option 1 (scanned Photograph and Signature as a single image)
Applicants are instructed to scan their recent passport size colour photograph & signature in an A4 sheet with 200 DPI resolution, dimensions should be minimum of 600 x 600 pixel and the file size should be less than 150KB. (as shown in guidelines video for uploading and cropping your photograph and signature during online application)
- 17.3 Option 2 (Scanned Photograph and Signature as separate images)
Applicants are instructed to scan their Photograph in JPEG format with 238 x 306 pixel dimension and the file size should be less than 50KB. Signature file format should be JPEG, dimensions should be 350x150 pixel and file size should be less than 30KB.
- 17.4 The photograph should have been taken recently, preferably within three months.
- 17.5 Read / View the Photograph & Signature (Text / Video) guidelines in the instruction page of the online portal <https://recruitment.py.gov.in> for guidance.
- 17.6 PREVIEW facility is available to view the details entered and please verify it before submitting the application.
- 17.7 After checking all the information provided, Click SUBMIT button without fail.
- 17.8 If the applicant fails to submit the application by clicking SUBMIT button after PREVIEW, the application will remain in PREVIEW stage only and it will not be considered as a valid application and it will be rejected, for which the Government will not be held responsible.
- 17.9 Candidates whose application remain in **PREVIEW** stage will not be allowed to write the examination.
- 17.10 Even after submission of application, corrections, if any, can be done before the closing date.
- 17.11 Keep a copy of the online generated application for your future reference.
- 17.12 Please logout/sign out after submission of application.
- 17.13 Online generated applications can be viewed in any standard PDF readers.
- 17.14 Please use latest web browser for better compatibility, better user experience and improved security.

- 17.16 The Department does not accept any responsibility for the candidates not being able to submit their applications within the last date on account of the aforesaid reasons or for any other reason beyond the control of the Department.
- 17.17 Application with incomplete data / information and improper photograph and signature is liable for rejection.
- 17.18 The information/data furnished by the applicants in the online application are final and cannot be altered after the closure of the application on 12.09.2025 at 03.00 pm.
- 17.19 Request for change of date of birth, category, etc. will not be entertained on any account after the date of closure.
- 17.20 The status of the application will be indicated in the Website <https://recruitment.py.gov.in>. The applicants are advised to check the official website to know their application status.

18. PROCEDURE FOR MERITORIOUS SPORTS PERSONS (MSP) APPLICANTS:

The candidates applying against MSP quota have to send copy of their online generated application along with self-attested photocopies of the relevant sports certificates issued by the competent authorities, superscribing on the cover as **"APPLICATION FOR DIRECT RECRUITMENT TO THE POST OF POLICE CONSTABLE UNDER M.S.P CATEGORY"** to **" The Special Officer (Police) , Police Department, Puducherry-605 001"** within the due date and time of **3.00 pm on 19.09.2025**. Belated applications will not be entertained.

19. Further instructions will be given to the candidates in the admit card of the respective tests.




GENERAL INSTRUCTIONS TO THE CANDIDATES

PART – I

20. Applicants should read the following instructions carefully before applying:
- 20.1 Mode of applying for Recruitment to the post of Police Constable is **only through online**. Avoid registering multiple online applications and register only one single application. All multiple online applications will be cancelled. In case of multiple online applications, only the latest application will be accepted and all other duplicate applications will be rejected.
 - 20.2 All candidates who register themselves in response to this advertisement by the closing date and time and whose applications are found to be in order will be provisionally accepted as per the terms and conditions of this Notice of Examination.
 - 20.3 Candidates must go through the requirements of educational qualification, age, etc. and satisfy themselves that they are eligible for the post.
 - 20.4 This Department will not undertake detailed scrutiny of applications for the eligibility and other aspects at the time of conduct of PST, PET and written examination and therefore, admission to the examination will be provisional only, which will not confer any right on such provisionally admitted candidates to claim appointment based on such provisional admission.
 - 20.5 Candidates are cautioned that they must ensure that they belong to the category as filled in the application form and are able to prove the same by furnishing the requisite certificate from the competent authority when such certificates are sought by this Department at the time of certificate verification, failing which their candidature will be cancelled. For example, candidate X filled OBC in his application form. However, during certificate verification, he is unable to produce the valid OBC certificate. In such scenario, candidature of X will be cancelled. Hence, candidates are advised to fill the application after ascertaining the category under which the caste he/she claims fall in the state list for OBC, MBC, SC, BCM, EBC, ST, BT, EWS.
 - 20.6 The Candidates who mention their category as MBC-Migrant/OBC-Migrant/ EBC-Migrant/ BCM-Migrant/ BT-Migrant/ /SC-others /ST-Migrant in their online application will be considered only under Unreserved category.
 - 20.7 The certificates/documents in support of their educational qualifications and caste/category, etc. shall be sought from the provisionally selected candidates at the time of Certificate Verification only.
 - 20.8 After verification of the certificates/documents of educational qualifications/caste/category, etc., if any claim made in the application is not substantiated by certificates/ documents, the candidature of candidate will be cancelled/rejected, without any notice.
 - 20.9 Admit Card for examination will be issued online on the websites of the Department. Candidates are therefore advised to regularly visit the websites of the Department.





- 20.10 All the communications with regard to this recruitment will be published in the Website <https://recruitment.py.gov.in>. Applicants are advised to visit the website and watch the news in dailies regularly for information. They are advised to keep the Mobile number given in the online application active for sending SMS connected with this recruitment.
- 20.11 Change of Address and Mobile number, if any, after submission of application should invariably be intimated to the Department by Registered Post with Acknowledgement due. Otherwise the Department will not be responsible for any delay/non-delivery of letters/SMS messages.
- 20.12 If candidates are found to indulge at any stage in any of the malpractices, will immediately be sent out of the PST/PET- Ground & Examination Hall, their candidature for this examination will be cancelled and strict legal action will be initiated including lodging of FIR and debarment from future examinations conducted by the Government of Puducherry.
- 20.13 "Use of calculator, laptop, palmtop or other digital instruments/mobile/cellphone/communication devices/ electronic devices/pager/Smart watches are not allowed inside the examination Venue. In case any candidate is found in possession of such items he or she would be debarred from the examination and legal proceedings will be initiated against the candidate."
- 20.14 The decision of the Government of Puducherry as to the eligibility or otherwise of the applicant for admission to the Examination shall be final.
- 20.15 A separate press note will be issued in leading regional news dailies regarding the issue of hall tickets through online. The eligible applicants can download their Hall Ticket from the Website <https://recruitment.py.gov.in> by using the "User Name and Password".
- 20.16 The applicant, after applying can also make corrections in their on-line application, if any error occurred while entering the data. They are allowed to avail this facility till **3.00p.m. On 12.09.2025**
- 20.17 The information /data furnished by the applicants in the online application are final and cannot be altered after the last date of applying i.e. **12.09.2025**.
- 20.18 Before submission of the applications / corrected applications, candidates must check that they have filled correct details in each field of the online form. After the closing date for receipt of online application i.e. 12.09.2025 no change / correction / modification will be allowed under any circumstances. Requests received in this regard in any form/manner Post, Fax, E-mail, by hand etc. will not be entertained by this Department and will be summarily rejected.
- 20.19 The applicants are advised to have a copy of the online generated application for their reference.
- 20.20 Applicants except MSP category candidates need not send the printout of the online application or any other supporting documents to this Department.
- 20.21 The candidates applying against MSP quota have to send the copy of their online generated application along with self attested photocopies of the relevant sports certificates issued by the competent authorities, superscribing on the cover as "APPLICATION FOR DIRECT RECRUITMENT TO THE POST OF POLICE CONSTABLE UNDER M.S.P CATEGORY" to **"The Special Officer (Police), Police Department, Puducherry-605 001"** within the due date and time of **3.00 pm on 19.09.2025**.



- 20.22 Candidates seeking reservation benefits available for SC/OBC/MBC/EBC/BCM/ST/BT/EWS must ensure that they are entitled to such reservation as per eligibility prescribed in the Notification. They should also be in possession of the certificates in the prescribed format in support of their claim.
- 20.23 After scrutiny, the status of the application will be indicated in the Website <https://recruitment.py.gov.in>. The applicants are advised to check the official website to know their application status.



Government of India, Ministry of Personnel, P.G. and Pensions, Deptt. Of Pers. & Training, New Delhi, Office Memorandum No.36034/21/87-Estt.(SCT), dated 7th November, 1989

Sub: Second time benefit to ex-servicemen for reservation in Groups 'C' and 'D' posts / services not allowed.

In this Department's O.M. No.36034/27/84-Estt.(SCT) dated 02.05.1985, it was decided that the second time benefit of ex-servicemen will not be admissible to those ex-servicemen who have already availed of the benefit of Ex-servicemen on their first re-employment in civilian posts. On the request made by Directorate General of Resettlement, Ministry of Defence, that the decision contained in the above OM dated 02.05.1985, should not be made applicable to those Ex-servicemen who have been re-employed or are reemployed by the Private Companies / Autonomous Bodies / Public Sector Undertakings and Government Offices on casual / contract/ temporary ad hoc basis and who can be removed by this Department and it has been decided that the provisions contained in this Department's OM No.36034/27/84-Estt.(SCT) dated 02.05.1985 shall not apply to those ex-servicemen who have been re-employed or are re-employed by Private Companies/Autonomous Bodies/Public Sector Undertakings / Government Offices on casual/contract/Temporary ad hoc basis and who can be removed from such service at any time by their employer concerned.




Government of India, Ministry of Personnel, P.G. and Pensions, Deptt. Of Pers. & Training, New Delhi, Office Memorandum No.36034/6/90-Estt.(SCT, dated 02.04.1992

Sub: Benefit of age concession to Ex-servicemen who have already joined Govt. Service for applying for employment in a higher grade / cadre under the Central Govt., Group C&D.

The Undersigned is directed to refer to this Department's O.M.No.36034/27/84-Estt.(SCT) dated 02.05.1985 wherein it has been clarified that on an ex-servicemen joining civil appointment he is deemed to be a civil employee and will accordingly be entitled to only such of the benefits like relaxation of age etc. as admissible to civil employees, in accordance with the existing instructions in this regard. Representations have been received requesting the Govt., to reconsider the above decision. The matter has also been raised by the staff side of the National Council (JCM) suggesting that at least the benefit of age relaxation should be allowed to those ex-servicemen candidates who have joined a civil post under the Govt., of India and who wish to improve their career prospects.

2. The matter has been examined in this Department in consultation with Ministry of Defence and the Department of Public Enterprises and it has now been decided that such of those ex-servicemen candidates who have already secured employment under the Central Govt., in Group C and D will be permitted the benefit of age relaxation as prescribed for ex-servicemen for securing another employment in a higher grade or cadre in Group C/D under the Central Govt., However, such candidates will not be eligible for the benefits of reservation for ex-servicemen in Central Govt., jobs.

The above decision is in modification of Provision of this Department's O.M.No.36034/27/84-Estt.(SCT), dated 02.05.1985.



Government of India, Ministry of Personnel, P.G. and Pensions, Deptt. Of Pers. & Training, New Delhi, Office Memorandum No.36034/1/2014-Estt.(Res.) dated 14.08.2014

Sub: Benefit of reservation to Ex-servicemen, who applies for various Examinations / vacancies before joining civil posts/services in the Government job on civil side.


In terms of this Department's Notification No.39016/10/79-Estt.(C), dated 15th December, 1979 as amended from time to time and which was last amended vide Notification No.36034/1/2006-Estt (Res) dated 4th October, 2012 the benefit of reservation to ex-servicemen is available at ten percent of the vacancies in Group C posts and twenty percent of the vacancies in Group D posts in all the Central Civil Services and posts. Benefit of reservation is also extended at ten percent of vacancies in the posts up to the level of Assistant Commandant in all Para-military forces to be filled by direct requirement.

Vide this Department's O.M.No.36034/27/84-Estt.(SCT), dated 02.05.1985, it was decided that once an ex-servicemen has joined the Government job on civil side after availing of the benefits given to him as an ex-serviceman for his re-employment, his ex-serviceman status for the purpose of re-employment in Government would cease. It was also decided that on his joining the civil employment, he would be deemed to be a civil employee and would accordingly be entitled to only such of the benefits like relaxation of age etc, as admissible to civil employees in the normal course. Vide this Department's O.M. No.36034/21/87-Estt.(SCT) dated 07.11.1989, it was clarified that the instructions of 02.05.1985 shall not apply to those ex-servicemen who have been re-employed or are re-employed by private companies / autonomous bodies / public sector undertakings / government offices on casual / contract / temporary ad-hoc basis and who can be removed from such service at any time by their employer concerned.

An ex-serviceman at the time of his release or discharge from the armed forces normally applies for more than one vacancy, but in case he/she is not entitled for the benefit of reservation for ex-servicemen for subsequent employment. It has been brought to the notice of this Department that the aforesaid instructions are affecting the chances of ex-servicemen in the case of direct recruitment for subsequent suitable employment.

The matter has, therefore, been considered in consultation with Department of Ex-servicemen, Ministry of Defense. It has now been decided that if an ex-servicemen applies for various vacancies before joining any civil employment, he/she can avail of the benefit of reservation as ex-serviceman for any subsequent employment. However, to avail of this benefit, an ex-serviceman as soon as he/she joins any civil employment should give self-declaration / undertakings to the concerned employer about the date-wise details of application for various vacancies for which he/she had applied for before joining the initial civil employment. Further, this benefits would be available only in respect of vacancies which are filled on direct recruitment and whenever reservation is applicable to the ex-servicemen.

The above Orders shall take effect from the date of issue of this Office Memorandum.
